

## Contest rules “Tryangle Website Easter Egg Hunt”

### Article 1 - Organiser of the contest

The organiser is Tryangle Happiness & Wellbeing at Work ([www.tryangle.be](http://www.tryangle.be)).

### Article 2 - Duration of the contest

The contest runs from 19 May 2022 at 12:00 to 30 May 2022 at 23:59. The selection of the winners and the award ceremony will take place on Tuesday 31 May 2022.

### Article 3 - Conditions of eligibility for the competition

- The competition is open to any adult with a physical address in Belgium - to send the physical prize.
- The organiser is not allowed to take part in the competition himself.

### Article 4 - Conditions of participation

- Register and send a fully correct code by using the form on <http://eepurl.com/c8xd7v>.
- A person who wishes to participate more than once by sending in several codes, each time using a different e-mail address, can only be declared a winner once and can therefore only win 1 prize (for the first code he or she has sent through and for which he or she is the first one to claim it).

### Article 5 – Allocation of the prizes

- On the website [www.tryangle.be](http://www.tryangle.be), 5 unique codes can be found on different web pages. There are 3 on Dutch pages, 1 on a French page and 1 on an English page.
- Every individual participant who has sent a correct code using the registration form will be eligible for the competition.
- An incorrect code (due to a typing error in the text or the absence of some letters or numbers) will not be considered as a correct entry.
- Codes sent through via e-mail or through social media channels will not be considered.
- At the end of the competition, for each of the 5 codes, we will check who is the first person to 'claim' it (= based on the time of registration using the form). The time stamp in our Mailchimp database will unambiguously determine for each code who sent it first and who will be the winner for this code.
- This way, a maximum of 5 winners will be determined, who will each will be awarded a Tryangle surprise / prize.

### Article 6 - announcement of the winners and award of prizes

- On Tuesday 31 May 2022, the winners will be announced on Tryangle's social media channels.
- The winners will be personally notified before the announcement on our Social Channels via the e-mail address they used to participate.
- People who have not reacted after 48 hours to accept their prize and provide their address (to send the prize), will forfeit their prize and a new winner will be determined for this code (i.e. the second fastest registration to claim this exact code).
- A specific individual can only win one prize, even if they participate with different e-mail addresses to send though multiple codes.
- Each prize awarded is nominative and cannot be exchanged for another product or service.
- If a code is not found and claimed before the contest ends, there will be no winner for this code.

### Article 7 - General terms and conditions of the competition

The "Tryangle Website Easter Egg Hunt" competition is free of charge and is organised between May 19<sup>th</sup> 2022 12:00 and May 30<sup>th</sup> 2022 23:59. Participation outside this timeframe will not be taken into account. Each participant can participate more than once, but only one prize per person will be

awarded (based on the first code he sent in for which he was the first entrant). The organiser reserves the right to exclude participants who would harm the spirit of the competition.

#### Article 8 - Connection and use

The organisers are not responsible for any misuse of the internet access, the receipt of materials or any other technical connection that prevents the successful completion of the competition. Internet participation in the contest implies knowledge and acceptance of the characteristics and limitations of the internet, particularly with regard to technical performance, the response time to consult, retrieve or transmit information. The lack of protection of certain data against possible diversions and the risk of contamination by viruses circulating on the network shall not be the responsibility of the organisers.

#### Article 10 - Acceptance of the rules

Participation in the competition implies acceptance of the rules, available on the website [www.tryangle.be](http://www.tryangle.be) throughout the duration of the competition.

Any lack of information or misrepresentation of identity or address will automatically result in the elimination of the participant from the competition. The organisers reserve the right to verify the accuracy of information provided by participants.

#### Article 11 - Incidents - Liability

The organisers reserve the right to cancel, modify, postpone, terminate, curtail or extend the competition if circumstances beyond his control force him to do so. It cannot be held liable for these changes. Organisers may communicate about these changes in any appropriate manner. In no circumstances can the organisers be held liable for any material or bodily injury suffered by a participant or a third party as a result of participating in the competition.

#### Article 12 - Settlement of disputes

Any complaint must be made in writing to one of the organisers by email at the latest within the month following the announcement of the winners on May 31st 2022.

In the event of a dispute, the parties shall attempt to resolve their dispute amicably. Otherwise, all disputes or cases not covered by these rules shall be decided by the organisers, and the decision shall be final.
